

**CITY OF PASS CHRISTIAN  
APPLICATION FOR GOLF CART/ LOW – SPEED VEHICLE PERMIT**

In accordance with City of Pass Christian Ordinance, each qualified person desiring to operate a golf cart or low – speed vehicle on the designated streets of the Timber Ridge Subdivision (see map attached) shall first submit an application in person to the City Clerk to obtain, after inspection by the Police Department, its own individual permit/decal to be placed on the cart or vehicle; the decal shall be affixed to the left rear fender of the cart or vehicle so as to be fully visible when the cart or vehicle is in operation. A registration fee of \$25.00 for each permit, as well as \$5 for decal, shall be payable at the time of registration/inspection and shall be effective for as long as the registering owner owns the cart or vehicle. Golf carts and Low – Speed Vehicles shall have all equipment listed in the City Ordinance (see attached). All drivers must have a valid driver's license or temporary learner's permit and proof of financial responsibility or liability insurance coverage.

I agree to indemnify and hold harmless the City of Pass Christian, its officials, agents, and employees, for any and all claims or actions arising from the use or operation of this golf cart. I furthermore insure that I will obey all the laws and regulations pertaining to the operation of the golf cart or low-speed vehicle.
