I would like to thank the members of the Timber Ridge Community for their interest and recommendations on the proposed changes to the covenants and by-laws. The by-laws and covenant committee, made up strictly of members, was charged with communicating to the general membership regarding any questions or concerns pertaining to these documents.

The committee has completed this process and has submitted their recommendations to the Board. In my initial review, I have found many of the recommendations to be useful and appropriate. The Board is in the process of reviewing all suggestions and will address each recommendation. This will allow members to have a better understanding as to the inclusion or exclusion of a specific recommendation. For instance, as noted in my article in the April 2014 newsletter; The 1979 Covenants in Article 18 provided that the Covenants can only be amended by an instrument in writing filed with the Chancery Clerk of Harrison County containing the notarized signatures of a majority of lot owners in Timber Ridge. In 2008, we petitioned the Chancery Court of Harrison County, Mississippi to change that requirement for amendments as it was virtually impossible to achieve. Judge Sandy Steckler, by Order dated March 28, 2008, deleted the requirement of notarized signatures of owners to amend the Covenants and that a majority of the lots subject to the Covenants and Restrictions agree to any revision. The requirement, as it stands now, is that amendments are authorized by a majority of 60% of the ballots cast either in person or by proxy for any proposed amendment. recommendation was to require approval of 60% of all lot owners. With 1430+ individual lots and 950+ members the process of acquiring a 60% response, let alone a majority response to anything, is unattainable and prohibits the Association from evolving and the Board adjusting to current social, economic and cultural conditions.

Once the board completes and articulates its review the final revisions will be presented to the membership and a special meeting of the POA membership will be held in the near future.

Thank you again for participating in this vital process.



Timber Ridge as a Golf Cart Community by Brian Kett

Recently, new signs were posted at both the North Street and Henderson Avenue entrances indicating that Timber Ridge is a golf cart community and that our public roads are shared by cars, trucks and registered golf carts. It appears that with this new designation, many more home owners in Timber Ridge have now invested in registered golf carts to use within our community. The number of golf carts used at the swimming pool, tennis courts, and Treasure Point has increased.

In addition to the new "Share The Road" signs, the City of Pass Christian has also posted new Golf Cart Crossing signs in both directions on Fairway Drive, where golfers cross the road going from hole #2 to #3, and then again from hole #7 to #8.

Most Timber Ridge residents have properly registered their golf carts for use on Timber Ridge public roads with the City Of Pass Christian, and are following the rules associated with the use of those golf carts on our community roads. A small number of our residents continue to put their own children and others at risk by allowing their under-aged children, that do not have valid driver's licenses, drive golf carts on our community roads. Several of the carts reported to be driven by children without driver's licenses, are the larger golf carts, equipped with four seats, and travel at higher rates of speed. Again, the POA would request that the owners of these vehicles ensure they are only driven by licensed operators, and not continue to put their own children and other members of our community at risk. Violators should be reported to the City police for ticketing



What are the rules?

- ✓ All golf carts and low speed vehicles must be registered with the City of Pass Christian
- ✓ Driver must possess a valid Driver's License or Learner's Permit
- ✓ Owner must show proof of financial responsibility (Liability insurance)
- ✓ Driver must obey all rules of the road
- ✓ Number of people in a cart may not exceed the maximum capacity specified by the manufacturer
- ✓ No person may ride on any part of the cart not designed to carry passengers

On average, American homes are victims of burglary about every 15 seconds, according to the U.S. Department of Justice. Fortunately, Timber Ridge does not have anything close to this. This is possible through successful teamwork from former and current TRPOA members, neighborhood watch programs, camera monitoring systems, security patrols and most importantly you. You, as home owners who care about your property and your neighbor's property, are responsible in making Timber Ridge a very safe place to live and raise a family. To keep it that way and to improve for the future, the board will continue to work with local law enforcement and look at ways to make security the most efficient for the neighborhood. Over the following months, I will provide a list of suggestions that will help make your home safer from the threat of burglary. The entire list can be e mailed to you or I will have copies at the TPOA office for you to pick up. With the national economy getting worse, burglary is again becoming a more common crime. Timber Ridge is a prime area for burglary. With many of the homes being second houses, that are empty most of the time, they are an excellent target for a break in. Thieves do ride around in their vehicles and "case out" good neighborhoods. They look to see who is not in and the pattern that a house is non-occupied. Two examples I came across last week were outside lights left on during the day (multiple days and nights) and the other was empty garbage cans sitting on the street in front of the house days after the trash pickup was done. Studying these over a period of a week, I quickly could determine that the home was a possible target. If I could do it, any thief could also!! These are very simple things to fix. One with a daylight sensor that cuts off during the day and the other is asking a neighbor to roll the empty can back to the house after the pickup. Neighbors, you might want to do it without being asked. Kindness is a good thing, plus if the burglar was robbing that house, at the same time, they might see something in your backyard that they might want. These are both very small, simple suggestions that could prevent a robbery.

As mentioned, the TRPOA, the Pass Christian Police Department and the Security Company are working to make sure Timber Ridge stays safe and gets even better.
